CHANGES TO NHS SCOTLAND MILEAGE RATES

Summary

1. This circular informs NHS Scotland employers of the introduction of new mileage rates for hospital medical and dental staff and doctors and dentists in public health and the community health service.

Agreement

- 2. NHS employers and the BMA have agreed that mileage rates and regular user lump sums for hospital medical and dental staff and doctors and dentists in public health and the community health service will be adjusted in line with agreements reached in the NHS Staff Council where these are more advantageous. Previous rates that were higher than those in the current agreement will be held at their earlier value.
- 3. The new rates are set out at Annex A to this Circular and this Annex replaces the mileage rates set out in NHS Circular PCS(DD)2008/3.

4. Employers should implement this agreement, which has been approved by Scottish Ministers under Regulation 2 and 3 of the National Health Service (Remuneration and Conditions of Service) (Scotland) Regulations 1991 (SI 1991 No 537). A copy of the formal approval is attached.

*Crown cars, while used solely on NHS business, do not require to be taxed or insured for the purposes of the Road Traffic Act 1972; any private mileage requires that the vehicle be taxed and insured.
