AMENDMENT TO THE TERMS AND CONDITIONS OF SERVICE FOR HOSPITAL MEDICAL. DENTAL AND **PUBLIC HEALTH MEDICINE CONSULTANTS EMPLOYED UNDER** THE 2004 CONSULTANT **CONTRACT**

CHANGE TO CODE OF CONDUCT FOR PRIVATE RECOMMENDED **STANDARDS** PRACTICE FOR NHS CONSULTANTS (APPENDIX 8 OF THE CONTRACT)

Summary

This Circular notifies employers of a change to the 1. Contract (Scotland) 2004 Consultant **Terms** Conditions of Service (TCS) by the removal of a principle previously applied in circumstances where NHS patients wished to pursue private treatment concurrently with their NHS treatment. The principle to be removed is that set out under Paragraph 2.13 (1st bullet) of the Code of Conduct for Private Practice: Recommended Standards of Practice for NHS Consultants (Appendix 8 of the TCS) which states that:

"A patient cannot be both a private and an NHS patient for the treatment of one condition during a single visit to an NHS organisation".

Context

The removal of this principle is required because 2. the Scottish Government has issued new guidance to replace CMO(2007)3 and which supersedes the principle This revised guidance provides a framework to support decisions concerning the possible combination of elements of NHS and private care for individual patients. 3. BMA (Scotland) and NHS Employers (via the Management Steering Group (MSG)) have agreed the change.

Cabinet Secretary Approval

4. Employers should implement this agreement, which has been approved by Scottish Ministers under Regulation 2 and 3 of the National Health Service (Remuneration and Conditions of Service) (Scotland) Regulations 1991 (SI 1991 No 537). A copy of the formal approval is attached.

Amendments to TCS

5. The text of the TCS will be amended to reflect these changes and a revised copy of the TCS will issue in due course.

Action

- 6. NHS Boards, Special Health Boards and NHS National Services Scotland (formerly the Common Services Agency) are required to note the deletion of the first bullet point of paragraph 2.13 of Appendix 8 of the Terms and Conditions of Service for the 2004 Consultant Contract from the date of this circular.
- 7. A High Court judgement in 2006 highlighted the need for NHS employers to take all reasonable steps to ensure that the effects of nationally negotiated collective agreements are incorporated into individual contracts of employment.
- 8. It is good practice that NHS employers should:
 - write to individual medical and dental practitioners in order to notify them of the revision to the TCS; and
 - place a copy of the notification on each individual's HR record.
